

## RATIFICATION TABLE

At 7<sup>th</sup> March 2013, 19 Member States<sup>1</sup> of the 25 signatories including 13 Eurozone States<sup>2</sup> have already ratified the Budgetary Pact.

The Foundation has updated this table which provides an overview of the ratifications in the various Union countries.
